Cheekwood Welcomes New Board Trustees

NASHVILLE, Tenn. – Cheekwood Estate & Gardens welcomes eight new Board Trustees whose initial three-year term began January 1, 2024. Officers:

Ronald Roberts, Chair, is a managing partner for Finn's Nashville Office and leads its client retention program. Matt has also served as Chairman of the Tennessee Business Roundtable, the Adventure Science Center's board, the Nashville Public Library Foundation, Studio Bank and is a founding board member and former Chairman of the Tennessee Advanced Energy Business Council.

Josh Trusley, Treasurer, is a partner at Ernst & Young, where he leads audit engagements for public and private companies, assists companies with capital raising activities, M&A, and leads consulting engagements related to the deployment of new technologies. Josh has served on the Cheekwood Finance Committee since 2020. He was recognized as one of Nashville Business Journal's 40 under 40 in 2018.

Katherine Crosthwaite, Secretary studied Theatre at University of Tennessee from 1978 to 1980 and then Columbia College from 1920 – 1982. Katherine worked at Continental American Insurance in Columbia, South Carolina from 1982 until 2009 as a Corporate Secretary and Event Planner. She was involved with the Junior League of Columbia and a community volunteer and Tiffany Circle donor at the American Red Cross.

About Cheekwood

With its intact and picturesque vistas, Cheekwood is distinguished as one of the leading Country Place Era estates in the nation. Formerly the family home of Mabel and Leslie Cheek, the 1930s estate, with its 30,000-square-foot Mansion and 55-acres of gardens, today serves the public as a botanical garden, arboretum, and art museum with furnished period rooms and permanent collection galleries devoted to American art from the 18th to mid-20th centuries. The property includes 13 distinct gardens including the Blevins Japanese Garden and the Bracken Foundation Children's Garden, as well as a 1.5-mile woodland trail featuring outdoor monumental sculpture. Each year, Cheekwood hosts seasonal festivals including Cheekwood in Bloom, Summertime at Cheekwood, Cheekwood Harvest and Holiday LIGHTS. Cheekwood is listed on the National Register of Historic Places and is accredited by the American Alliance of Museums and nationally as a Level II Arboretum. It is a three-time voted USA Today Top 10 Botanical Garden and in 2021 was recognized by Fodors as one of the 12 Most Beautiful Gardens in the American South. Cheekwood is located eight miles southwest of downtown Nashville at 1200 Forrest Park Drive. It is open Tuesday through Sunday 9 a.m. – 5 p.m., with extended days and hours of operation depending on the season.
